I refer to previous e-mail communication with Reference 10/2/12/3-633/2019

In line with the directions I received by the NPA office (letter attached) I am introducing new supporting evidence regarding my previous statement on pending cases of the Cato Manor unit:

-Case Malvern CAS 32/04/2007 and Pinterown Lcrc 730/04/2007-

I have previously submitted video footage that I personally took while on duty as a Police reservist at the above crime scene, in the company of Gen. Booysen. This video has been officially handed to the investigation team and members of the NPA, back in Athens of the South African embassy in 2017.

After examining clause 5.3 of the Lcrc report (attached) and compared the two photos marked exhibit F, of page 14 ,with my own video recording submitted as evidence of the crime scene ,I have discovered that there was no firearm at the specific location ,contrary to the Lcrc report of page 14 exhibit F.

In fact, if the video recording is to be carefully examined, it is visible that the female police officer is standing on the exact same spot on my left, where the alleged firearm is supposed to be located. However, that will be impossible because her feet will be stumbling on the firearm. I was positioned next to her. I never show a firearm and thus I never recorded or photographed it. Even the second firearm located by the already deceased suspect, within the combi vehicle, was pointed out to me much later by another police officer on the crime scene, after he had moved the body of the deceased !This is proven by the sequence of my photos taken that night ,where within a 20 minutes period ,the body had been moved within the vehicle and the firearm magically appeared and pointed out to me in order to photographed it. The embedded time stamps of the photos provided to the NPA as evidence will collaborate my claims.

It is highly unlikely that a trained police detective such as the female Cato manor officer on the scene will be positioned herself on top of such crucial evidence such as a suspect's loaded and cocked firearm! The same goes for Gen. Booysen.

Furthermore, in the reflection of the left door of the red car, there is no indication of the firearm in place, all though the back wall is clearly mirrored through the car door as a reflection. (of my video recording)

By observing the size of the floor tiles as reference to determine space and distance, the photo of the alleged firearm provided and my video recording .as well as the position of the officers involved, one can clearly determine that the firearm was not there at the time of my recording.

It is my believe that the firearm was deliberately placed at the particular spot by Cato manor members after I took the video recording of the crime scene, thus interfering with a crime scene and breaking the law.
